Grand Jury Hears Insurance Fraud and Tampering With a Witness Cases

Criminal District Attorney Richard Glaser reports that on Thursday, May 23, 2024, the Grand Jury met in a lengthy session and reviewed evidence in eighteen (18) cases. The Grand Jury returned seventeen (17) true bills or indictments listed below, and one (1) case was No Billed. The Fannin County Grand Jury has returned 127 true bills of indictment so far in 2024.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
