## **Accident Involving Death Greets New Grand Jury**

Criminal District Attorney Richard Glaser reports that on Thursday, July 18, the newly impaneled Grand Jury for the July Term convened for their first formal session. At that initial session and after some brief instructions in the workings of a Grand Jury, fourteen (14) cases were presented for their consideration. The Grand Jury returned twelve (12) true bills or indictments and two (2) cases were passed for additional information. So far in 2024, a total of 161 cases have been charged in Fannin County.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
