

## PRESS RELEASE

### Theft and Assault Charges Presented to Grand Jury

Criminal District Attorney Richard Glaser reports that on Thursday, September 19, 2024, the Grand Jury met and reviewed evidence in twenty-eight (28) cases. The Grand Jury returned twenty-seven (27) true bills or indictments listed below; one case was No Billed. The Fannin County Grand Jury has returned 195 true bills of indictment so far in 2024.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
