### Multiple Sexual Charges Presented to Grand Jury

Criminal District Attorney Richard Glaser reports that on Thursday, October 24, 2024, the Grand Jury met and reviewed evidence in nineteen (19) cases and the Grand Jury returned nineteen (19) true bills or indictments listed below. The Fannin County Grand Jury has returned 212 true bills of indictment so far in 2024.

It is important to note that an indictment is a formal charge and should not be considered as evidence of guilt and that all persons charged with a crime are presumed innocent until proven guilty beyond a reasonable doubt.
